**COMMISSION ACTIONS**

**CANDIDATE STATUS**

Candidate Status is granted to institutions that are in Basic Compliance with the TRACS Standards. Basic Compliance is the determination by the Accreditation Commission that an institution is in full compliance with all Standards related to the Institutional Eligibility Requirements (IERs) and has the ability to be in Substantive Compliance with all of the Accreditation Standards within the period of candidacy. Candidacy is for a period of up to five years. During that time, each institution must come into compliance with all TRACS Standards, conduct a Self-Study, host an Evaluation Team, and appear before the Accreditation Commission for Accredited Status. To maintain Candidate Status, the institution must remain in compliance with all IER-related standards.

The following institutions were granted Candidate Status by the TRACS Accreditation Commission after completing a successful self-study and being evaluated by an on-site evaluation team:

**REAFFIRMATION OF ACCREDITED STATUS**

Reaffirmation is granted to institutions that are in Substantive Compliance with the TRACS Standards. Substantive Compliance indicates that the Accreditation Commission has determined that an institution's level of compliance is sufficient to warrant accreditation and that the institution can come into full compliance with all the Accreditation Standards within a maximum of two years. Reaffirmation is for a period of ten years with an Interim Fifth Year Review (IFYR). For the next Reaffirmation cycle, the institution must complete a successful self-study, host an on-site team evaluation, respond to the team recommendations, and appear before the Accreditation Commission.

## **REMOVE FROM SANCTION – SHOW CAUSE**

**Paine College** (1235 Fifteenth Street, Augusta, GA 30901)

At the April 27-28, 2026, meeting, the TRACS Accreditation Commission voted to remove Paine College from Show Cause and to grant the institution Reaffirmation I of Accredited Status as a Category II institution for a period of five years. The institution is required to submit a follow-up Compliance Report addressing remaining in progress Recommendations by September 1, 2026, for consideration by the Accreditation Commission at the October 2026 Commission meeting.

**Visible Music College** (200 Madison Ave., Memphis, TN 38103)

At the April 27-28, 2026, meeting, the TRACS Accreditation Commission voted to remove Visible Music College from Show Cause. The institution has demonstrated compliance with TRACS Standards.

## **REMOVE FROM SANCTION – PROBATION**

**Reformed University** (1724 Atkinson Road, Lawrenceville, GA 30043)

At the April 27-28, 2026, meeting, the TRACS Accreditation Commission voted to remove Reformed University from Probation. The institution has demonstrated compliance with TRACS Standards.

## **CONTINUE INSTITUTION ON SANCTION – WARNING**

**Bethesda University** (730 North Euclid Street, Anaheim, CA 92801)

At the April 27-28, 2026, meeting, the TRACS Accreditation Commission voted to continue BU on Warning due to the institution's non-compliance with TRACS Standards 11.1 (IER) and 13.1 (IER). The institution is required to submit a Compliance Report addressing these areas of non-compliance no later than September 1, 2026, for consideration by the Accreditation Commission at the October 2026 Commission meeting.

## **PLACE INSTITUTION ON SANCTION – PROBATION**

**Boston Baptist College (BBC)** (950 Metropolitan Avenue, Boston, MA 02136)

At the April 27-28, 2026, meeting, the TRACS Accreditation Commission voted to place BBC on Probation due to the institution's non-compliance with TRACS Standards 11.1 and 11.2 (both Institutional Eligibility Requirements). The institution is required to submit compliance reports, including a teach-out plan and addressing these areas of non-compliance, for consideration by the Accreditation Commission at the October 2026 Commission meeting.

**Epic Bible College and Graduate School (EBCGS)** (4330 Auburn Boulevard, Sacramento, CA 95841)

At the April 27-28, 2026, meeting, the TRACS Accreditation Commission voted to place EBCGS on Probation due to the institution's non-compliance with TRACS Standards 11.1 and 11.2 (both Institutional Eligibility Requirements). The institution is required to submit compliance reports, including a teach-out plan and addressing these areas of non-compliance, for consideration by the Accreditation Commission at the October 2026 Commission meeting.
