Continued Under ACCREDITED – PROBATION Status

Issued by the Accreditation Commission on November 17, 2025

Reformed University: The following information is provided by the Transnational Association of Christian Colleges and Schools (TRACS) regarding the current status of Reformed University (RU). The information presented is made available in accordance with TRACS policy. Neither the TRACS Accreditation Commission nor the staff of TRACS will make further comment regarding this institution.

What action has the TRACS Accreditation Commission taken against Reformed University?

On April 28, 2025, the Commission voted to place RU on Probation. On October 20, 2025, the Commission voted to continue RU on *Probation*. This status will be reviewed by the Commission at the April 2026 Commission meeting.

What is the accreditation status of Reformed University? The institution will maintain the current *Accredited – Probation* status until the April 2026 meeting of the Accreditation Commission.

What will happen at the next meeting? At the April 2026 meeting, the TRACS Accreditation Commission has the following options:

If the institution demonstrates compliance with the Accreditation Standards, TRACS policies and procedures or any applicable Federal Regulations within the timeframe allowed, the Accreditation Commission will remove the institution from Probation.

If the institution has not corrected its deficiencies and demonstrated compliance with the issues in question within the timeframe allowed, the Accreditation Commission will either:

- Continue the institution on Probation;
- Place the institution under a more severe Sanction (Show Cause) as deemed appropriate, with the total time allowed for demonstrating compliance not to exceed the maximum timeframe allowed; or
- Take Adverse Action against the institution.

Why was the accreditation of Reformed University changed to *Accredited - Probation*? This action of the Accreditation Commission was based on the determination that the institution's non-compliance with the Accreditation Standards, TRACS policies and procedures or any applicable Federal Regulations is significant and / or concerns one or more of the Accreditation Standards associated with an Institutional Eligibility Requirement, and rises to the level where the institution's ability to fulfill its mission or to provide a quality educational experience consistent with that associated with an accredited post-secondary institution is in question.

This determination reflects a level of non-compliance which must be corrected by the institution and requires the imposition of a Sanction by the Accreditation Commission. It is a level of non-compliance which, in the professional judgment of the members of the Accreditation Commission, the institution must correct immediately and which the institution has, or can reasonably obtain, the resources needed to correct.

Specifically, the Commission found that RU could not demonstrate compliance with TRACS Standards 11.1, 11.2, and 17.12 (all Institutional Eligibility Requirements). The institution is required to submit a Compliance Report addressing these areas of non-compliance by March 1, 2026, and submit a revised Teach-Out Plan that meets the requirements of TRACS Policy BP224 for consideration by the Accreditation Commission at the April 2026 Commission meeting.
